Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2019-20 educational progress for the Lake Linden-Hubbell Public Schools (K-12). The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2019-20 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given. Our school was not identified with any of these labels.

Lake Linden-Hubbell is constantly working to update our curriculum, modernize our technology, secure more technology, and provide our students with a practical education that they can use outside of the school. We appreciate the continued support of our parents, staff and community in our efforts.

State law requires that we also report additional information. New students enrolling at Lake Linden-Hubbell are asked to register with the office immediately. Parents must present a state-birth certificate, immunization verification, and proof of residency upon enrollment. Students attending grades K-5 will be in the elementary building, those attending grades 6-12 will be assigned to the high school building.

The Lake Linden-Hubbell School Improvement Plan has been developed by school and community members. It is annually reviewed and modified as needed.

Specialized programs are available to our high school students through the Copper Country ISD. They include programs in nursing, health careers, auto mechanics, cybersecurity, and mechatronics. Also, efforts are made to match students with classes that meet their intellectual, social, or personal needs.

Lake Linden-Hubbell's core curriculum is based on state standards and benchmarks included in the Michigan Grade Level Content Expectations and Common Core Standards. The School Improvement Team, goal committees and classroom teachers are constantly reviewing data, including test scores, to keep the curriculum aligned to the standards. Any variances from the state's model are data based and become necessary when differentiating instruction to meet the needs of diverse learners. A listing of course offerings and descriptions can be obtained from each office, as well as the alignment to the Grade Level Content Expectations. No local competency tests are administered by Lake Linden-Hubbell Schools. In addition, there are no nationally normed achievement tests.

Lake Linden-Hubbell Schools offer parent/teacher conferences twice a year. Attendance results for the 2018/2019 and 2019/2020 school years are listed.

Elementary Building

High School Building

2018 (Fall) 75 (37%) 2019 (Spring) 43 (22%)

2019 (Fall) 81 (38%) 2020 (Spring) 72 (33%)

High Schools are also required to report the following information:

- Number and percent of post-secondary enrollments: 2018/2019- 17 (12.5%)
2019/2020- 13 (11.2%)
- Number of college equivalent courses: There were 62 college courses taken during the 2018/2019 school year and there were 53 college courses taken during the 2019/2020 school year.
- Number and percentage of students receiving a score leading to college credit: In 2018/2019, 17 of 17 students who took college courses passed all 62 of the courses leading to college credit in all of them. In 2019/2020, all 13 students passed all their combined 53 courses resulting in college credit.

We are very proud of the accomplishments of our students and staff and the support that we receive from our community. We are constantly reviewing

our students' progress and look to make the necessary curriculum changes as needed.
