Board of Education  
Regular Meeting  
December 8, 2025**

A Regular Meeting of the Lake Linden-Hubbell Schools Board of Education was held in Room 102 of the High School building on Monday, December 8, 2025. The meeting was called to order by President Patricia Burton at 5:30 p.m.

A motion was made by Jennifer Beaudette and supported by Jeff Dennis to approve a one-time, off schedule payment to support staff. Roll call vote. Motion unanimously carried.

A tentative date was set for a Special meeting on January 19, 2026 at 5:30 p.m. The meeting will only be necessary if the bid results for the bond project are not available by the January 12, 2026 Regular meeting.

The possibility of getting new kitchen equipment in the first round of bond projects is being investigated.
